TROPICAL CYCLONE NANAUK/ 02 A IN ARABIAN SEA

I am directed to state that Pakistan Meteorological Department has issued a Cyclone Advisory-3 (last) dated 14th June, 2014 1400 hours relating to Tropical Cyclone Formation in Arabian Sea, which is reproduced as under:

The Tropical Cyclone 02A (Nanauk) has weakened into a well marked Low Pressure Area (LPA) in the central Arabian Sea during last 24 hours. This well marked LPA has moved northeastwards with a gradual decreasing trend during last 06 hours and now located at Lat. 21.2°N and Long. 64.0 about 530 kms in southwest of Karachi. There is high probability of its dissipation over the water of north Arabian Sea in next 2-3 days.

Under the influence of this well marked LPA some isolated rain/thundershowers are expected in lower Sindh during next 2-3 days. The fishermen of Sindh may resume their

- In view of above, it is requested that necessary preparedness measures be taken and all the equipment / manpower be kept on high alert and ready to respond quickly to any situation. It may also be ensured that the District Emergency Operations Centers shall be operationalized round the clock in case of any adverse situation.
- The PEOC at PDMA Headquarter shall remain operational 24/7 during this phase. P.E.O.C. contact numbers are 021-99251458-9.
- For their own safety, the fisherman may be directed not to venture in open seas and may resume their activity from tomorrow.
