Subject: HEATWAVE WARNING

I am directed to refer to the subject cited above and to state that Pakistan Meteorological Department has issued Heat wave Warning on 06.10.2017. The contents of the warning are as under:

"Due to the developing low pressure area off Indian Coast in the Arabian Sea, the sea breeze along Pakistani Coastline will weaken. Under such conditions, temperatures along Pakistan coastal areas including Karachi will gradually increase during the next 4-5 days resulting into moderate heat wave conditions.

Daytime high temperatures in Karachi may cross 40°C on Tuesday and Wednesday.

PMD will keep the public and concerned authorities informed 3 days ahead of the most likely heat wave situation.

2. It is therefore, requested to kindly take appropriate necessary action accordingly to avoid any eventuality.
