## Subject: - HEAVY RAINS EXPECTED IN SINDH

I am directed to state that Pakistan Meteorological Department has informed that heavy rains are expected in Sindh during the coming 5-6 days, also accompanied by splash-streams of water. This may result in further overflow in the river Indus to approximately 500000 – 550000 cusecs water at Guddu and Sukkur Barrages from 24<sup>th</sup> July, 2015 onwards. The cumulative effect may worsen the prevailing river situation and may cause urban flooding.

- 2. Accordingly, it is requested to ensure that all preparedness measures be put in place in your district, including activation of Rain Emergency Centre / District Emergency Operation Centre round the clock manned by well-versed staff and officers for an effective response mechanism including early warning and evacuation of vulnerable communities wherever required. It shall be ensured that sufficient resources including dewatering pumps are pre-deployed at low lying areas.
- 3. Since urban flooding in major cities cannot be ruled out, all out efforts be made to minimize the chances of hazards associated with rainfall and urban flooding. The following authorities are requested to take actions as mentioned below:
  - I. **DISTRICT ADMINISTRATIONS / DDMAS:** (i) to take all precautionary measures to avoid any untoward situation. Ensure establishment of tent relief camps for evacuated population having all allied facilities like availability of drinking water, food, health and livestock facilities etc. (ii) to monitor the overall situation including measures taken by relevant departments.

- II. **HEALTH / PPHI:** (i) Ensure availability of all required medicines / vaccines and sufficient staff at hospitals; (ii) special mobile hospitals may be established at tent relief camps
- III. LIVESTOCK & FISHERIES: To ensure availability of sufficient vaccines and fodder at tent relief camps
- IV. **HOME DEPT.** To deploy appropriate police force to assist the district administration for evacuation operations, vigilance and patrolling

V. IRRIGATION DEPT: To monitor the river situation and take appropriate precautionary measures as per contingency plan

VI. K-ELECTRIC/HESCO/SEPCO: (I) Ensure uninterrupted power supply to pumping stations for drainage of rain water. (ii) Secure electric transmission lines in case of high winds. (iii) Ensure prompt action to avoid electrocution due to fallen electric wires.

VII. **KWSB/WASA (HYD):** Ensure drainage of water from the low lying areas of the city.

VIII. **DHA/CANTONMENTS:** (i) Removal of loose structures, billboards, hoardings, and (ii) drainage of rain water through the nallahs, etc.

IX. KMC / HMC / MMC / NSUSC / TMAs: (i) To ensure that all the drainage/nallahs have been cleaned to facilitate smooth and quick drainage of water. (ii) Upkeep of Dewatering Pumps, Pumping Stations and other machinery to timely drain the water.

X. **SBCA:** To take timely necessary preemptive action with reference to old/dangerous building structure prone to structure collapse.

XI. **INFORMATION DEPT:** To ensure timely dissemination of information through print and electronic media.

It is requested to kindly keep the PDMA Sindh promptly informed (via return fax on **021-99251463**) regarding implementation of this 'alert' and also in pursuance of your District Disaster Management Plans and also keep PDMA informed on the District Emergency Operation Centers, contact number and contact person, resource earmarked by the respective DDMAs to combat the current situation.
