RIVERS SITUATION AND QUALITATIVE FLOOD FORECAST

I am directed to refer to Pakistan Meteorological Department's Flood Forecasting Division Bulletin No A-84/20 and No B-84/20 dated 6th September 2020, forecasting as under:

HYDROLOGICAL SITUATION:

River Indus at Taunsa, Guddu & Sukkur is in Medium Flood level while at Kalabagh & Chashma is in Low Flood Level.

<u>Alert</u>: River Indus at <u>Guddu</u> is likely to attain <u>High Flood Leve</u>l during 08th to 09th September-2020 and at <u>Sukkur</u> during 09 th to 10th September-2020.

Weak seasonal Low lies over Northeast Balochistan
