Subject: WEATHER WARNING (FROM 29TH AUGUST, 2017 TO 2ND SEPTEMBER, 2017)

I am directed to refer to the subject noted above and to state that Pakistan Meteorological Department (PMD) vide its Weather Warning dated 29th August, 2017 (1000 PST) has intimated that:

"A strong monsoon weather system from India is heading towards Sindh and likely to enter in southeast Sindh in the evening of Tuesday the 29th August 2017. Under its influence widespread rain/thundershowers with a number of moderate to heavy and few very heavy falls with strong gusty winds may occur in Lower divisions of Sindh including Karachi & at scattered places in upper divisions of Sindh from 30th August to 1st September 2017. Heavy falls may generate urban flooding in vulnerable areas of lower Sindh. Fishermen are advised to take precautionary measures and not to venture in deep sea till 2nd September 2017".

3. It is therefore, requested to kindly ensure that all precautionary measures are taken to avoid any untoward situation and effective response mechanism may kindly be adopted including early warning.
