Subject: **WEATHER WARNING FOR SINDH**

I am directed to refer to the subject noted above and to state that Regional Forecasting Center Karachi has issued Weather warning, dated 09-08-2019, (copy enclosed) and has forecasted that monsoon Depression now lies over central parts of India, likely to move westwards and reach eastern Sindh around today's evening. Under the influence of this system widespread rains/wind-thunderstorms with a few moderate to heavy falls may occur in Thar, Mirpurkhas, Thatta, Badin, Hyderabad and Shaheed Benazirabad districts and in Karachi division from 9th August to till the morning of 12th August 2019.

2. Heavy falls may generate urban flooding in Karachi, Mirpurkhas divisions, Thatta, Badin and Hyderabad districts on Saturday and Sunday.
3. It is therefore requested to remain alert during the predicted rains and take all precautionary measures accordingly, please.
