## SUBJECT: - RIVERS SITUATION AND QUALITATIVE FLOOD FORECAST:

## **HYDROLOGICAL SITUATION:**

River Indus at Kalabagh & Chashma and River Kabul at Nowshera are in Medium Flood Level, River Indus at Tarbela, Taunsa, Guddu & Sukkur is in Low Flood level.

## II: METEOROLOGICAL FEATURES:

- a) Yesterday's Monsoon low over Bahawalpur Division has become insignificant.
- b) Yesterday's trough of westerly wave over Kashmir & adjoining area persists.
- c) Seasonal Low lies over Northeast Balochistan.
- d) Moderate moist currents from Arabian Sea & Bay of Bengal are penetrating upper parts of the country up to 5000 feet.

## II: WEATHER FORECAST FOR NEXT 24-HOURS:

Scattered wind-thunderstorm/rain with one or two heavy falls is expected over the upper catchments of all the Major Rivers along with Rawalpindi, Gujranwala, Sargodha, Lahore, Faisalabad, Sahiwal & Bahawalpur Divisions. Isolated wind-thunderstorm/rain is expected over Peshawar, Kohat & DI Khan Divisions.
