DEPRESSION OVER SOUTHEAST PAKISTAN AND SOUTHWEST RAJASTHAN

Pakistan Meteorological Department has informed that the Cyclonic Storm (CS) “BIPARJOY” over Rann of Kutch (India) and adjoining Southeast Pakistan (Tharparker) moved further Northeastward during last 12 hours, converted into a Depression and now lies over Southwest Rajasthan (India) and Southeast Pakistan (Tharparker) near Latitude 24.4°N & Longitude 71.2°E. The associated maximum sustained surface winds are 30-40 Km/hour gusting 50 Km/hour. The system is likely to move further Eastward and weaken into a low-pressure area over Rajasthan (India).

This is the final bulletin in this regard.

Possible Impacts:

- More rain-thunderstorms with few heavy falls & accompanied with gusty winds of 30-40 Km/hour gusting 50 Km/hour expected in Tharparker, Umerkot and parts of Badin districts today.
- Rain-thunderstorms expected in Thatta, Sujawal & Mirpurkhas districts
- Fishermen of Sindh can resume their activities from tomorrow.





Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairman DDMA's and other relevant authorities/ stakeholders may take all necessary measures. including:

1. Ensure vigilant monitoring of the cyclone associated effects i.e., rains and winds and establish proactive coordination with Provincial Emergency Operation Center (PEOC).
2. Ensure relief camp management and necessary arrangement for evacuees.
3. The evacuees be informed that their return shall be ensured after safety check of their dwellings by the concerned government authorities and lifting of **EVACUATION WARNING**. After warning is over, the public is advised to check and ensure safety of their homes before entering premises with families.
4. Ensure arrangement for dewatering, removal of fallen trees and debris from roads and settlements.
5. Ensure deployment of dewatering machines at low lying / vulnerable areas with respect to urban flooding.
6. Ensure functionality of pumping stations.
7. Reinstallation of bill boards shall not be allowed till effects of winds and wind gusts are over.
8. Loose installations such as, antennas, solar panels, and alike equipment on roofs shall be removed or reassured for safety during wind forecast.
9. Execute Contingency plans and relief distribution and management protocols
10. People may be advised not to park their vehicles near weak structures.
11. Coordinate with concerned Provincial/Federal departments/divisions respectively, including the National Highway Authority (NHA), Frontier Works Organization (FWO), Works and Services Department and Irrigation Department to analyze and plan for any potential harm to roads, bridges, and other vital infrastructure.
12. Ensure that the tools and materials needed for quick response and recovery operations, such as clearing roads and resuming utility services, are readily available.
