HEAVY MONSOON RAINS ALERT

Subject: **DEPRESSION OVER NORTHEAST ARABIAN SEA.**

Pakistan Meteorological Department (PMD) vide its heavy monsoon rains alert dated: 14.08.2022, has informed that the Depression over North Arabian Sea has weakened into a low pressure area over there with low over Rajasthan, India now lies as a through over there. Another low pressure area is likely to approach Sindh from 16th August

Under the influence of this weather system:

Rain-thunderstorms with few moderate/heavy falls likely to occur in **Shaheed Benazirabad, Noshero Feroz, Khairpur, Sukkur, Larkana, Ghotki, Kashmore, Shikarpur, Jacobabad, Dadu, Jamshoro, Kambar Shahdadkot, Tharparker, Umerkot, Mirpurkhas, Badin, Tando Muhammad Khan, Tando Allayar, Hyderabad, Matiari, Thatta, Sujawal, Sanghar districts & Karachi division on today & tomorrow.**

- The rain-thunderstorms activity likely to become intense and widespread in all above-mentioned districts from **16 Aug to 18 August.**
- Intense rain spell to continue in northeastern & southern districts of Balochistan which may trigger flash flooding in **Dadu, Jamshoro, Kambar Shahdadkot** districts & downstream.

Possible Impacts

- Heavy falls may create water-logging/urban flooding in low lying areas of **Hyderabad, Badin, Thatta, Sujawal, Umerkot, Mirpurkhas, Sanghar, Tando Muhammad Khan, Tando Allayar, Dadu, Noshero Feroz, Jamshoro, Kambar Shahdadkot, Larkana & Sukkur** districts and **Karachi Division** during **16-18 August.**
- Persistent heavy rains over Khuzdar, Lasbella and Hub distts of Balochistan & over Kirthar Range may create extra pressure on Hub dam, Thaddo dam & downstream nullahs.
- Sea conditions likely to remain rough & fishermen of Sindh are advised to avoid going in deep sea till today evening.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.

- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
