HEAVY MONSOON RAINS ALERT

Subject: <u>DEPRESSION OVER NORTHEAST ARABIAN SEA.</u>

Pakistan Meteorological Department (PMD) vide its heavy monsoon rains alert dated: 15.08.2022, has informed that the low pressure area over North Arabian Sea has become less marked with another low pressure area likely to approach & affect Sindh from tomorrow to 18th Aug.

Under the influence of this weather system:

Rain-thunderstorms with few moderate falls likely to occur in Shaheed Benazirabad, Noshero Feroz, Khairpur, Sukkur, Larkana, Ghotki, Kashmore, Shikarpur, Jacobabad, Dadu, Jamshoro, Kambar Shahdadkot, Tharparker, Umerkot, Mirpurkhas, Badin, Tando Muhammad Khan, Tando Allayar, Hyderabad, Matiari, Thatta, Sujawal, Sanghar districts & Karachi division today & tomorrow.

- The rain-thunderstorms activity likely to become intense and widespread in all above-mentioned districts from 16 Aug to 18 Aug.
- Intense rain spell to continue in northeastern & southern districts of Balochistan till 19th Aug which
 may trigger flash flooding in Dadu, Jamshoro, Kambar Shahdadkot districts & downstream.

Possible Impacts

- Heavy falls may create water-logging/urban flooding in low lying areas of Hyderabad, Badin, Thatta, Sujawal, Umarkot, Mirpurkhas, Sanghar, TandoMuhammad khan, Tando Allayar, Dadu, Noshero Feroz, Jamshoro, Kambar Shahdadkot, Larkana & Sukkur Districts and Karachi Division during 17-18 Aug.
- Persistent heavy rains over Khuzdar, Lasbella and Hub districts of Balochistan & over Kirthar Range may create extra pressure on Hub dam, Thaddo dam & downstream nullahs.
- Sea conditions likely to remain rough & fishermen are advised to remain careful while in deep sea.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMAs and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency reliet/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.

- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period. DSmy 15/08/22
