**HEAVY MONSOON RAINS ALERT**

**Subject: TORRENTIAL MONSOON RAINS/FLASH-URBAN FLOODING ALERT IN SINDH.**

Pakistan Meteorological Department (PMD) vide its heavy monsoon rains alert dated: 20.08.2022, has informed that the monsoon low-pressure area over Upper Sindh after producing torrential rains has weakened and merged with seasonal low over Balochistan. Another strong low pressure area currently located over eastern India likely to approach Sindh from **23<sup>rd</sup> August** which may cause again moderate/heavy rain-thunderstorms during **23<sup>rd</sup>-25<sup>th</sup> August**.

**Under the influence of former weather system:**

Rain-thunderstorms with few moderate/heavy falls likely to continue in **Shaheed Benazirabad, Noshero Feroz, Khairpur, Sukkur, Larkana, Ghotki, Kashmore, Shikarpur, Jacobabad, Dadu, Jamshoro, Kambar Shahdadkot** districts till tomorrow morning.

- Light/moderate rain likely in **Tharparker, Umerkot, Mirpurkhas, Badin, Tando Muhammad Khan, Tando Allayar, Hyderabad, Mityari, Thatta, and Sujawal Districts.**
- The continuing wet spell over northeastern & southern districts of Balochistan to persist till **22<sup>nd</sup> August** which may trigger flash flooding in **Dadu, Jamshoro, Kambar Shahdadkot Districts** & downstream.

**Possible Impacts**

- Heavy falls may worsen the situation already here is submerged areas in **Dadu, Noshero Feroz, Kambar Shahdadkot, Larkana, Jacobabad Shaheed Benazirabad, Ghotki, Shikarpur & Kashmore Districts.**
- Persistent heavy rains over Khuzdar, Lasbella and Hub districts of Balochistan & over Kirthar Range may create extra pressure on Hub dam, Thaddo dam & downstream nullahs.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.

- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

**FOR GENERAL PUBLIC**

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
