**HEAVY MONSOON RAINS ALERT**

**Subject: THE MONSOON LOW-PRESSURE AREA OVER CENTRAL SINDH HAS WEAKENED AND NOW LIES OVER UPPER SINDH AND ADJOINING BALOCHISTAN.**

Pakistan Meteorological Department (PMD) vide its **Weather Warning Dated:25.08.2022**, has informed the well-marked monsoon low-pressure area now lies over **Central Sindh** and adjoining Balochistan.

**Under the influence of this weather system:**

- Rain-thunderstorms with few moderate (isolated heavy) falls likely to continue in **Sukkur, Larkana, Ghotki, Kashmore, Shikarpur, Jacobabad, Dadu & Kambar Shahdadkot** districts till tomorrow morning.
- Light rain/drizzle is likely in **Tharparker, Umerkot, Mirpurkhas, Badin, Tando Muhammad Khan, Tando Allayar, Hyderabad, Mityari, Thatta, Sujawal, Shaheed Benazirabad, Naushahro Feroze, Khairpur & Sanghar** districts.
- The wet spell to continue over northeastern & southern districts of Balochistan till tomorrow night which may trigger flash flooding in **Dadu, Jamshoro, Kambar Shahdadkot** districts & downstream.

**Impacts:**

- Heavy falls may create more water logging in **Larkana, Shikarpur, Jacobabad, Dadu & Kambar Shahdadkot** districts.
- Persistent heavy rains over **Khuzdar, Lasbella and Hub distts of Balochistan** & over **Kirthar Range** may create extra pressure on **Hub dam, Thaddo dam & downstream nullahs.**

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.

- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

**FOR GENERAL PUBLIC**

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
