Subject: **SPECIAL ADVISORY REGARDING EID-UL-ADHA**

I am directed to refer to the subject cited above and to state that due to an ongoing Monsoon Season along with rise in Covid-19 and Lumpy Skin disease cases it has been advised that following precautionary measures should be taken during Eid-ul-Adha.

- a. Proper disposal of animal waste after Uzahi.
- b. Disposal of stagnant water from underpasses.
- c. Strict compliance with Covid-19 SOPs during Eid prayers and gatherings.
- d. Suitable lightening in Graveyards.
- e. Avoid passengers on roof of buses.
- f. More patrolling on highways during Eid days.
- g. Availability of Ambulances at main points on Highways.
- h. Availability of Livestock Veterinary doctors in Cattle Farms (*Animal Mandeas*) to check any case of lumpy skin disease.
- i. Sacrificial Animals to be kept at distance from each other to avoid outbreak of lumpy skin disease and other contagious animal diseases.
- j. Availability of handwashing facility or sanitizers at the entrance and exit of Cattle Farms (*Animal Mandeas*).
