**WEATHER OUTLOOK**

Subject **DUST-THUNDERSTORM/RAIN OF LIGHT/MODERATE INTENSITY WITH  
ISOLATED HEAVY FALLS IS LIKELY TO OCCUR AT A FEW PLACES IN  
SINDH**

Pakistan Meteorological Department (PMD) has informed vide its Weather Outlook dated 10<sup>th</sup> September, 2022, that a low-pressure area has formed over Indian Gujarat and adjoining areas.

**Under the influence of this Weather System:**

- **Dust-thunderstorm/Rain of light/moderate intensity with isolated heavy falls** is likely to occur at a few places in **Tharparker, Umerkot, Badin and Mirpurkhas districts** from **today to 14 September**, while in **Tando Muhammad Khan, Sujawal and Thatta districts** from tomorrow to 14 September.
- **Karachi** to experience **hot & humid weather** during **next 3 to 4 days** with maximum temperature to remain **39-41C**.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen District Disaster Management Authority and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

**FOR GENERAL PUBLIC**

- Move to safe places in case of any risk of Flash Flooding.

- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
