WEATHER OUTLOOK

Subject HOT AND HUMID WEATHER IS LIKELY TO PREVAIL IN MOST PARTS OF THE PROVINCE

Pakistan Meteorological Department has informed vide its Weather Outlook dated 31st July 2022, that, **hot and humid weather** is likely to prevail in most parts of the province. However, **isolated thunderstorm/light rain** may occur in **Sukker, Larkana and Jacobabad** districts, while **light rain/drizzle** along the coast including Karachi.

Outlook for the next 48 hours:

Hot and humid weather is likely to prevail in most parts of the province, while **light** rain/drizzle is expected along Sindh coast including **Karachi**.
