WEATHER WARNING

Subject RAIN-WINDSTORM/THUNDERSHOWER EXPECTED IN SINDH PROVINCE

Pakistan Meteorological Department (PMD) has informed vide its press release dated 30th June 2022, that, moist currents likely to penetrate from Arabian Sea & Bay of Bengal in eastern Sindh from 2 July. Under the influence of this weather system: Widespread Rain-Windstorm/Thunder Showers (with a few Heavy Falls, very heavy at times) are likely to occur in **Tharparker**, **Umerkot**, **Sanghar**, **Badin**, **Mirpurkhas**, **Thatta**, **Hyderabad**, **Tando M. Khan**, **Tando Allayar**, **Karachi**, **Dadu & Jamshoro** Districts during 2 - 5 July. Scattered Rain-Windstorm/Thunder Showers with isolated Heavy Falls also expected in **Nawabshah**, **NosheroFeroz**, **Sukkur**, **Larkana**, **Khairpur**, **Shikarpur**, **Qambar Shahdadkot**, **Ghotki**, **Kashmore** districts during the period.

POSSIBLE IMPACTS:

- Heavy Rains may trigger Urban Flooding in Karachi, Hyderabad, Thatta, Badin, Mirpurkhas, Umerkot & Dadu Districts.
- Rains will prove beneficial for Rice Crop growing.
- Water Stress is likely to ease
- Sea conditions may become Rough/Very Rough during 3rd to 5th July. Fishermen are advised to take extra care during the period

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMAs and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid
