**WESTERLY WAVE IS LIKELY TO APPROACH IN BALOCHISTAN FROM TODAY AND SPREAD GRADUALLY OVER CENTRAL/UPPER SINDH FROM TOMORROW.**

Pakistan Meteorological Department has informed that a westerly wave is likely to approach in Balochistan from today and spread gradually over central/upper Sindh from tomorrow. Under its influence: Few dust-thunderstorms/rain are likely in Jamshoro, Dadu, Sanghar, Mirpurkhas & Umerkot districts today. Wind-dust/thunderstorms/ rain with a few moderate to isolated heavy falls and hailstorm in Dadu, Sanghar, Khairpur Mir's, Sukkur, Ghotki, Kashmore, Shikarpur, Jacobabad, Larkana, Kambar Shahdadkot, Shaheed Benazirabad, Naushahro Feroze, Matiari, Hyderabad, Tando Muhammad Khan, Tando Allahyar, Mirpurkhas, Umerkot & Tharparker districts during 28-30 May.

**Possible Impacts**

- Wind-dust storm may cause damage to loose and vulnerable structures and standing crops in upper Sindh.

Keeping in view above, it is recommended that concerned Deputy Commissioner/ Chairman DDMA and other relevant authorities/ stakeholders may take all necessary mitigation measures, including:

- Establishment of helpline number to address needs of rain/flood affected people/IDPs at priority basis.
- Stockpile necessary emergency relief/ medicine stores especially in flood affected areas.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

**FOR GENERAL PUBLIC:**

- Monitor the weather alerts through print and electronic media.
- Stay indoor unless absolutely necessary. Keep doors and windows shut and avoid sitting near windows as rain is often accompanied by strong winds.
- Maintain a distance from power lines or electrical wires. If you notice any loose electric wires in your area, alert the authorities immediately.
- Avoid touching electrical switches or outlets while it is raining. Also avoid using electrical sockets or outlets outdoors while it is raining.
- Avoid driving in heavy rain because of poor visibility.
- Avoid underpasses, drainage ditches, low-lying areas and areas where water collects.
- Check on family members who are especially at risk from weather hazards: young children, older adults, and the chronically ill.
- Farmers are advised to remain cautious during the forecast period.
- General public is advised to stay at safe places during wind-dust/thunderstorms/ rain.
