SUBJECT: WEATHER WARNING


Met office informed that strong westerly wave producing heavy/very heavy rains in South Balochistan is likely to persist till 7th January 2022 with spreading over Sindh from today afternoon.

Under the influence of this weather system: widespread rain-thunderstorms with isolated heavy falls are likely to occur in Dadu, Jamshoro, Sh. Banazirabad, Jacobabad, Shikarpur, Sukkur, Larkana, Qambar Shahdadkot, Karachi, Hyderabad, Sanghar, Badin, Thatta, Mirpurkhas, T Allayar, T M Khan, Umerkot & Tharparkar districts till 7th January 2022.
