**WEATHER WARNING**

Subject: **THE WELL-MARKED LOW-PRESSURE AREA PERSISTS OVER NORTHEAST ARABIAN SEA AND ADJOINING RANN OF KUTCH, INDIA WITH ITS TROUGH EXTENDING UP TO SOUTHERN SINDH**

Pakistan Meteorological Department (PMD) has informed vide its Monsoon Weather Outlook, dated, 12<sup>th</sup> August, 2022, that, the well-marked low-pressure area persists over Northeast Arabian Sea & adjoining Rann of Kutch, India with its trough extending up to **southern Sindh**. The low-pressure over Rajasthan, India also persists.

**Under the influence of these Weather Systems:**

- **Rain-thunderstorms with a few heavy/very heavy falls & occasional strong winds** are very likely in **Tharparker, Umerkot, Mirpurkhas, Badin, Tando Muhammad Khan, Tando Allayar, Hyderabad, Matiari, Thatta, Sujawal, Sanghar, Shaheed Benazirabad, Noushero Feroz, Khairpur, Sukkur, Larkana, Ghotki, Kashmore, Shikarpur, Jacobabad, Dadu, Jamshoro & Kambar Shahdadkot districts & Karachi division** till **14<sup>th</sup> August** with occasional gaps.
- Rainfall intensity also to increase in northeastern and southern districts of Balochistan which may trigger flash flooding in **Dadu, Jamshoro, Kambar Shahdadkot districts & downstream.**

**Possible Impacts**

- Heavy falls may create water-logging/urban flooding in low lying areas of **Karachi, Hyderabad, Badin, Thatta, Sujawal, Tando Muhammad Khan, Tando Allayar, Dadu, Noushero Feroz, Jamshoro, Kambar Shahdadkot, Larkana and Sukkur** districts during the forecast period.
- Persistent heavy rains over Khuzdar, Lasbella, Hub distts & over Kirthar Range may create extra pressure on **Hub dam, Thaddo dam & downstream.**
- Sea conditions likely to remain **very rough till 14<sup>th</sup> August** & fishermen are advised to take extra care

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and staff during rainfall, at low lying areas.
- Improve coordination with emergency services, and line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

**FOR GENERAL PUBLIC**

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
