Subject: **Precautionary measures for upcoming spell of heat wave**

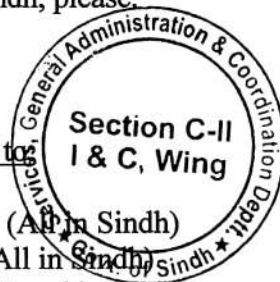
