Subject <u>MONSOON CURRENTS OF MODERATE INTENSITY ARE PENETRATING IN</u> EASTERN SINDH.

Pakistan Meteorological Department has informed that monsoon currents of moderate intensity are penetrating in eastern Sindh.

Under Its Influence:

- Dust-thunderstorm/rain with isolated heavy falls likely to occur in Tharparker, Umerkot, Mirpurkhas, Sanghar, Khairpur, Badin, Sujawal, Thatta & Jamshoro Districts today to 20th September with occasional gaps.
- Dust-thunderstorm/rain with few moderate falls may occur in Larkana, Dadu, Sukkur, Ghotki, Naushahro Feroz, Shaheed Benazirabad, Matiari, Hyderabad, Tando Muhammad Khan, Tando Allahyar and Kambar Shahdadkot districts during 18 -19 September with occasional gaps.
- Dust-thunderstorm/rain of moderate intensity likely in Karachi division on 18th September evening and 19th-20th September.

Possible Impacts:

- Prevailing very hot and humid conditions are likely to subside during the spell.
- Farmers are advised to manage their crop activities accordingly.
- Tourists and travelers are advised to remain cautious to avoid any untoward situation during the period.
- Wind-thunderstorm may damage loose structures like electric poles, solar panels etc.
- General public is advised to stay at safe places during wind-storm/lightning/heavy rains.

2. In view of the above, the Concerned Deputy Commissioner(s)/ Chairman DDMA(s) are requested to take necessary precautionary measures.
