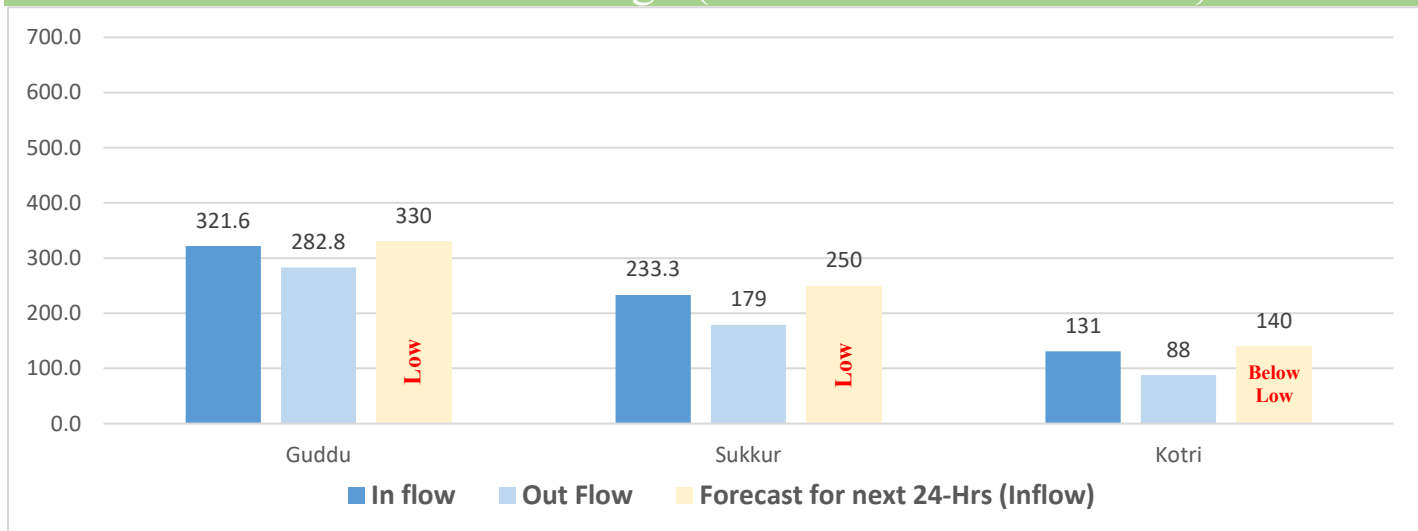

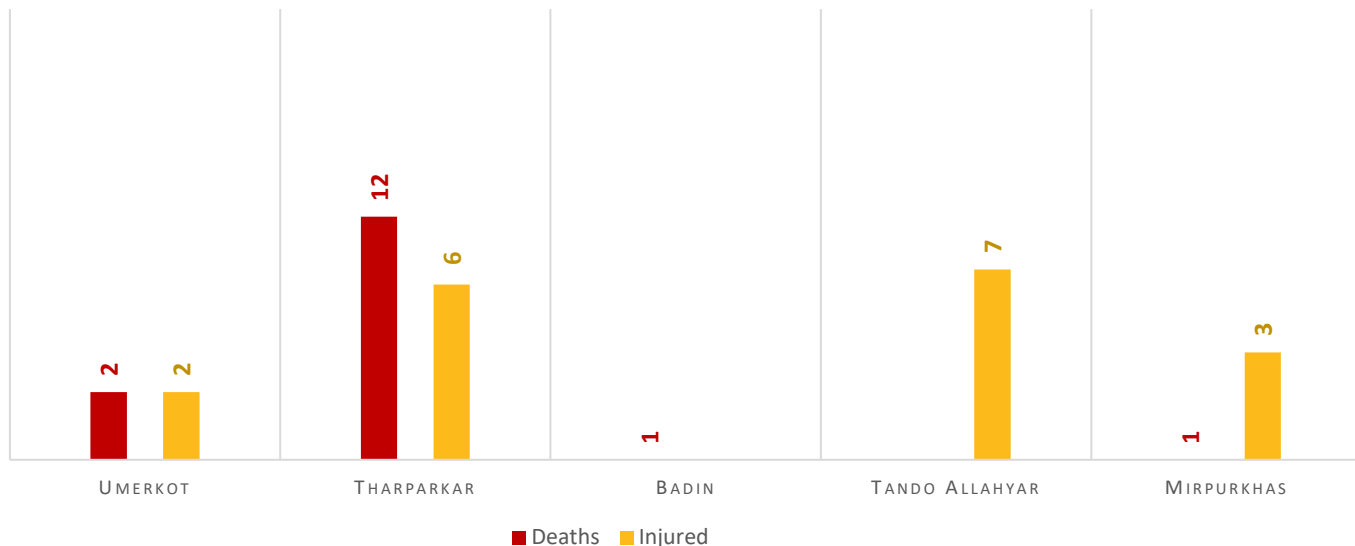

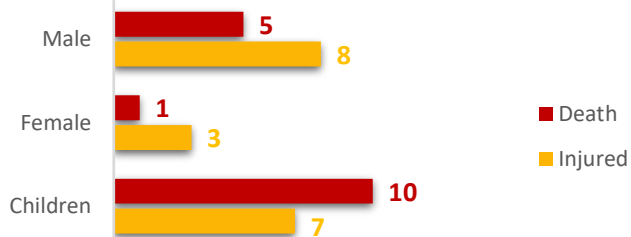

### DISTRICT-WISE DEATHS & INJURIES

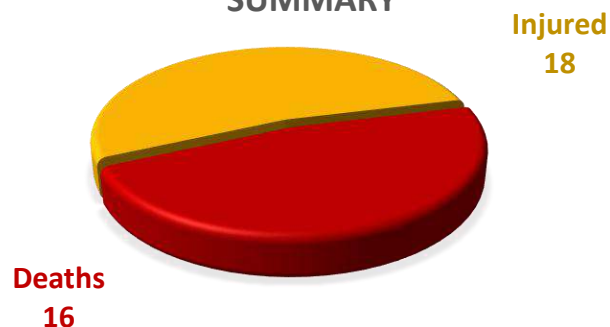

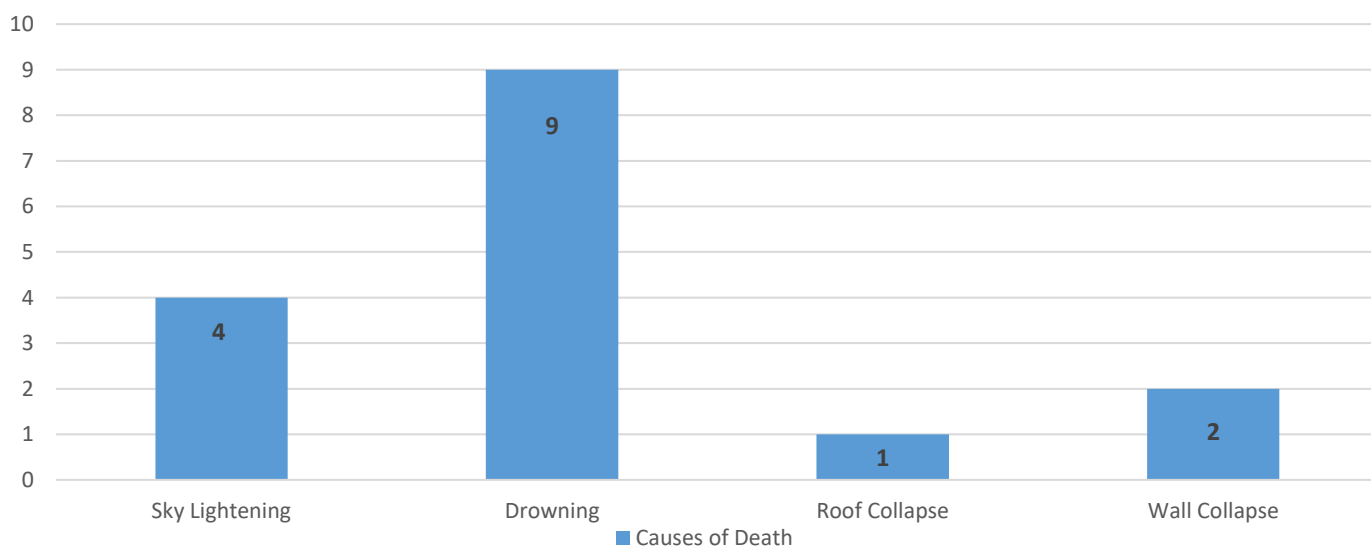
### GENDER-WISE DISTRIBUTION

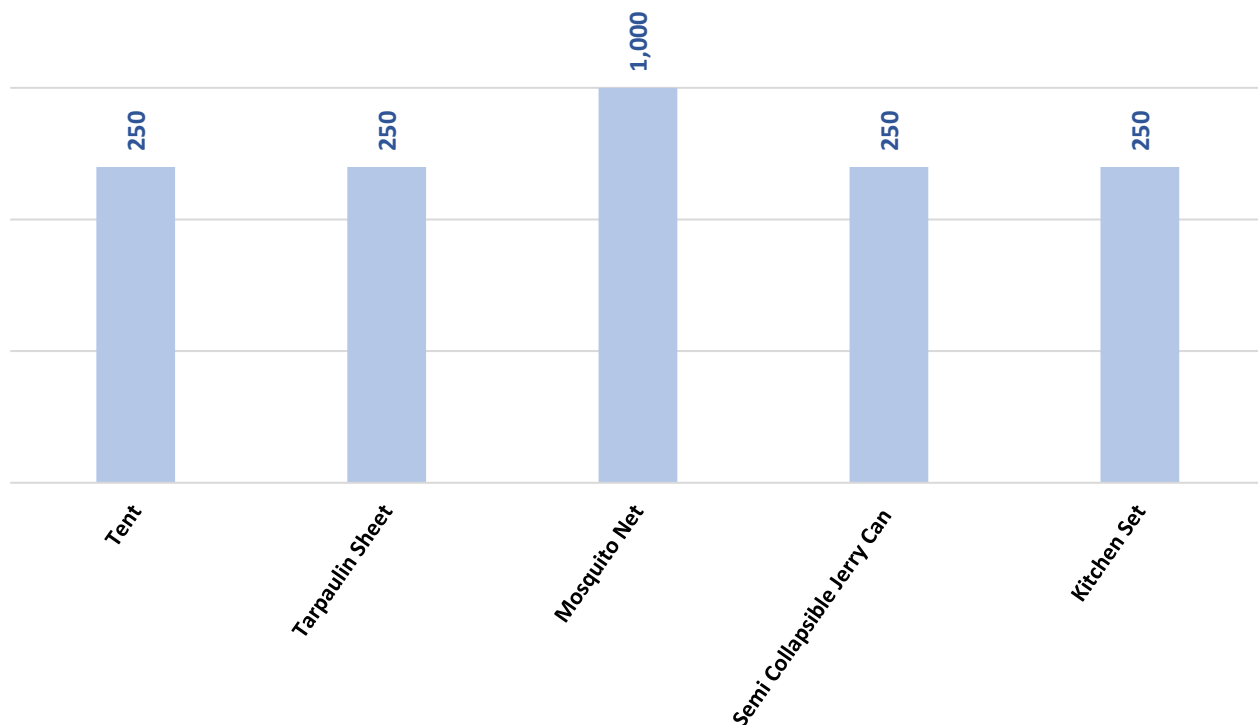
