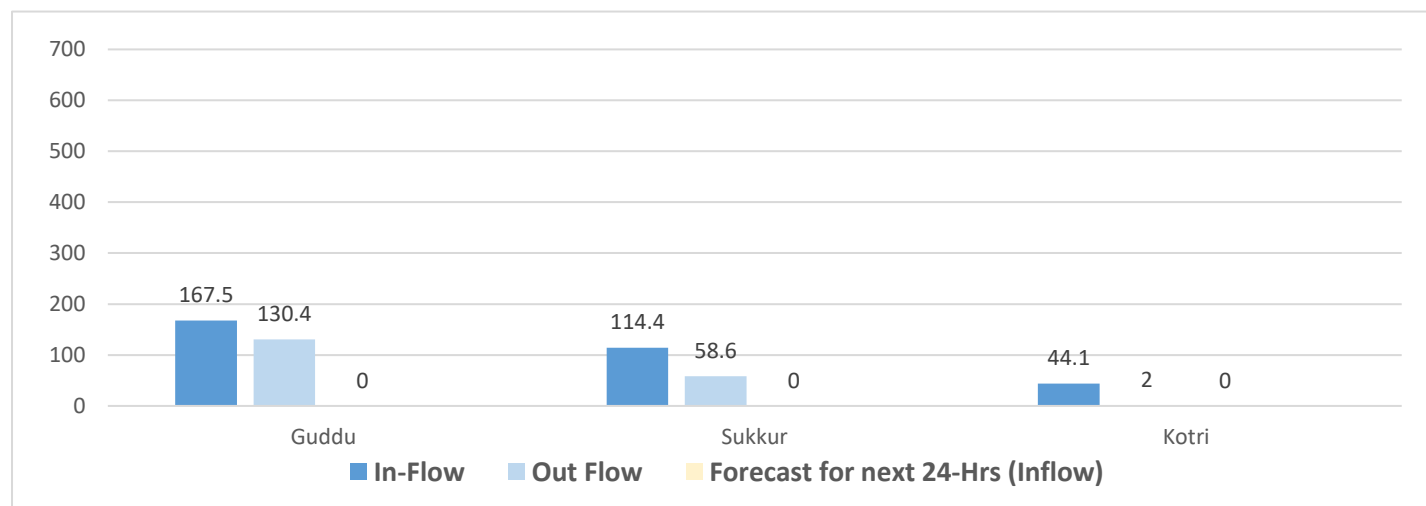
Weather Update Dated 24-07-2026

Pakistan Meteorological Department has informed that a low pressure area (LPA) is located over Southwest of Rajasthan and adjoining areas. Due to this (LPA) monsoon currents are penetrating in Southern and central parts of the country. Under the influence of this weather system:

- Rain-thundershowers with a **few heavy falls** expected in Tharparker, Umerkot, Mirpurkhas, Badin, Sanghar, Tando Muhammad Khan, Tando Allahyar, Hyderabad, Matiari, Jamshoro, Shaheed Benazirabad, Ghotki, Kashmore, Jacobabad, Shikarpur, Sukkur, Kambar Shahdadkot, Larkano, Khairpur, Naushahro Feroze & Thatta districts from **24th (evening/night) to 27th July** with occasional gaps.
- Mostly weather condition with chances of **rain-thundershower** also expected in **Karachi on 25th/26th July**.

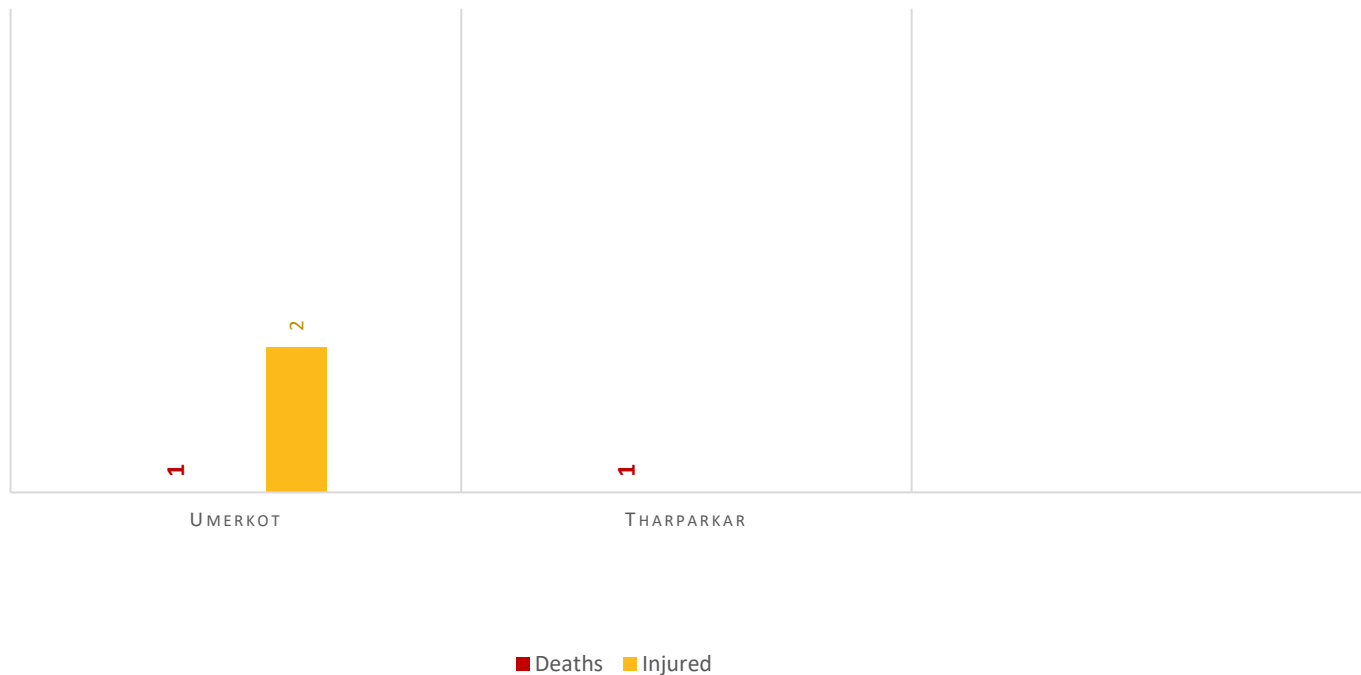

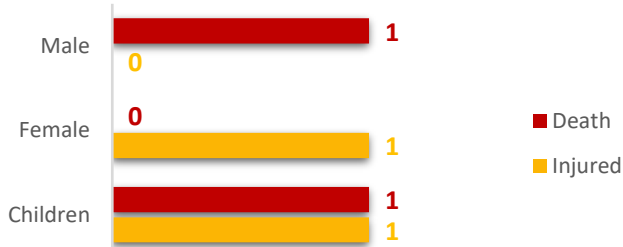


Cumulative Casualties – Deaths / Injuries (03-07-2026 to 24-07-2026)

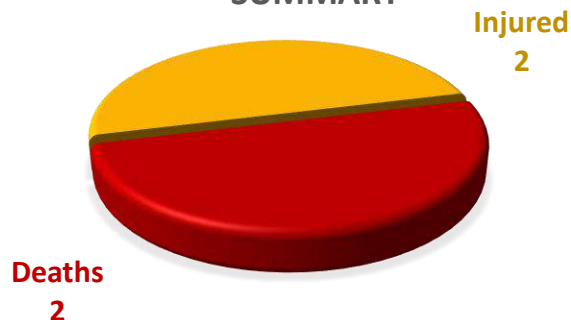
DISTRICT-WISE DEATHS & INJURIES



GENDER-WISE DISTRIBUTION

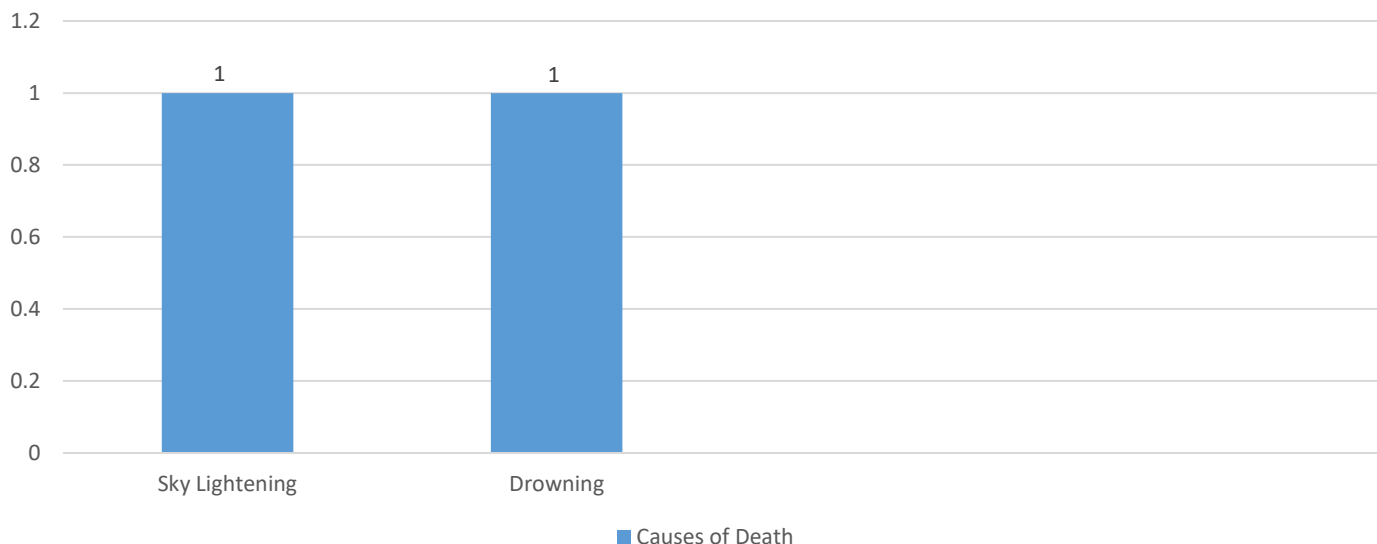
