TENDER NOTICE

The Provincial Disaster Management Authority (PDMA), Rehabilitation Department, Karachi invites sealed bids (with all applicable duties/taxes such as Income Tax, GST & Sindh Sales Tax) from interested bidders who must be "Active Tax Payer" for all applicable taxes, for the hiring of **Transportation Services** as detailed below in accordance with Sindh Public Procurement Rules (SPPRA) 2010 amended 2021.

Transportation services for the period of CFY 2022-2023 & FY 2023-2024	Rates for Shezor, Mazda, Mazda with crane, 6 wheelers, 10 wheelers, 18 wheelers, 20ft and 40ft trawler inclusive of all taxes, loading, unloading charges (where required) as per mileage & per hour rates of Excavator (chain/wheel driven), Tractor trolleys, Tractors for JHATTA pumps, Dumper & shovel loader (wheel driven).

2. Interested eligible bidders may either download the detailed Bidding Documents for the procurement of transportation services having specifications mentioned and terms & conditions from websites of PDMA (www.pdma.gos.pk) and SPPRA (www.pprasinhd.gov.pk) or can collect the Bidding Documents from PDMA Head Office during office hours from the date of publication of NIT till **03.05.2023** on payment of Rs.2,000/- per bid through Pay Order as Tender Fees (non-refundable) in favor of Provincial Disaster Management Authority Sindh. Those who download bidding documents from the website will have to submit the Tender Fees via Pay Order in the name of Provincial Disaster Management Authority Sindh amounting to Rs.2,000/- for each bid, at the time of submission of bid. The last date to submit the bids is **03.05.2023 till 1400 hours**. Bids will be opened in the presence of bidders on same day or their authorized representatives who choose to attend at **1430 hours on 03.05.2023** at the Committee Room of PDMA Sindh, Plot No 26 C, Main Khayaban-e-Jami, DHA Phase-VII, Karachi. Bids can be submitted along with 2 % Earnest Money in the form of Pay Order in the name of Provincial Disaster Management Authority, Sindh.

3. The proposal shall be submitted as single stage-one envelope; technical and financial proposal be placed inside a single envelope and clearly mentioning the bidders detail and seal. The competent authority reserves the right to reject all or any bid thereof if the forms provided in the bidding documents are not duly filled (along with sign & stamp of the bidder) or submitted without relevant documents & the bids are not found in accordance with Sindh Public Procurement Rules 2010 (amended 2021). The competent authority also reserves the right to reject any item or entire NIT without assigning any reason.

4. Rates should include all applicable taxes. Technical qualification criteria is available in the bidding document which will be strictly adhered to.
