






**MINUTES OF THE MEETING OF PROCUREMENT COMMITTEE REGARDING TECHNICAL & FINANCIAL  
BID OPENING FOR THE TENDER CONSTRUCTION OF BOUNDARY WALL ON PDMA SINDH LAND,  
KARACHI HELD ON 14.01.2020.**

A meeting of procurement committee of PDMA Government of Sindh was held on 14.01.2020 at 03:00pm in the committee room of PDMA Sindh under the Chairpersonship of Mr. Asif Jan Siddiqui, Deputy Director (F&A), PDMA Sindh/ Chairman PC along with other PC members and in the presence of the bidder who was present there. (Attendance sheet of the participants and the bidders is attached).

The Chairman apprised the participants that six (06) bids were sold and five (05) bids were received before the deadline. He also informed that as the single stage single envelope tendering process has been adopted for the said tender, therefore both technical and financial proposal will be opened and will be evaluated as per the technical criteria and least price method accordingly. All the five (05) bids were opened in the presence of the bidder and was found that two (02) bids i.e. of M/s Syed Rahim Shah and Brothers & M/s A.Majeed Payro Khan Mangi were disqualified on the technical grounds (detail as per Technical Evaluation Report ).

After the disqualification of the technical non responsive bidders there were three bidder who were technically qualified and their financial bids were evaluated on the lowest price/ cost method. The detail of which is as under:




