2. # MINUTES OF THE MEETING OF PROCUREMENT COMMITTEE REGARDING FINANCIAL EVALUATION FOR PROCUREMENT OF TRANSPORTATION SERVICES OF RELIEF ITEMS / GOODS / EQUIPMENT 2018-19 HELD ON 30.12.2018 (PPMS SPPRA NIT.# T0115-18-0001)

A meeting of procurement committee of PDMA Government of Sindh was held on 30.12.2018 at 10:30 am in the committee room of PDMA Sindh under the Chairpersonship of Mr. Zain ul Abidden Ansari, Deputy Director (F&A), PDMA Sindh/ Chairman PC and in the presence of the bidder who was technically qualified (attendance sheet of the participants and the bidders is attached).

In the light of decision made in the technical evaluation report, financial bid of only one technically qualified bidder / contractor was opened on the above mentioned date & time. Whereas, financial bids of three (03) firms were not opened being technically disqualified and were returned.

As there was only one bidder therefore, Rules 48 of SPPRA Rules 2010 (Ammended-2018) was exercised for the evaluation of rates of the single bidder for which the quoted prices were compared with the previously approved tender rates of transportation services issued by this authority as per award of contract dated: 25.04.2017(Annexure-A). The chair also requested the member PC from the transport department regarding the prevailing rate of diesel which was also considered in the comparison of rates of the successful bidder. There was maximum of around 40% and minimum of 19.88% increase deviation in the rates of the bidders. The PC also considered the fact that rates of the petroleum products have risen dramatically, the rates of the diesel was around Rs.80.48 in February, 2017 (during previous tender date), whereas, the current rates are at Rs.112.94 (as on November,2018) (the rates are taken from https://psopk.com/en/product-and-services/product-prices/hsd/hsd-archives) with the deviation of 40.33 % in the diesel rates (Annexure-B&C). Taking in consideration the inflated rates of fuel and other related facts like labor charges, maintenance cost of vehicle including lubricants, wear & tear & inflation) the current quoted rate was found acceptable by the Procurement Committee. The average quoted rise by the bidders stands to be approximately at 31.53 %.

The Procurement Committee unanimously decided that the rates are market compatible and justified as per the current prevailing scenario. The comparative statement of rates are placed at (Annexure-C). The PC recommended M/s Karachi Sitara Hilal Goods Transport Company for the award of contract on the basis of merit & last awarded contract rates.
