The meeting of the Procurement Committee notified vide letter No.SO-I(Rehab)3/14/2014/4016, dated 01.07.2024 for the procurement of Goods and Services through EPADS for FY 2024-25 for PDMA Sindh was held under the Chairmanship of Deputy Director (HQ&C), PDMA Sindh in PDMA Head office Karachi on 21.05.2025 at 1400. List of the participants is attached.

2. After welcoming the participants, the Chairman informed the committee that, Provincial Disaster Management Authority (PDMA) intends to initiate the procurement of essential goods required for operational readiness and administrative functions. The proposed procurement will be funded through the allocated administrative budget / proposed Revised Estimates (RE) for the financial year 2024-25 and 2025-26 and the reason for initiating of NIT at this stage is that the RE has recently been approved by Finance Department.

3. The purpose of this procurement is to ensure uninterrupted administrative operations, to run day to day office affairs and to maintain preparedness for any emergent situations, especially in wake of the upcoming monsoon season.

4. Moreover, this authority hired the services of transportation and skilled manpower through NIT in the current year 2024-25 which is going to expire on 31.07.2025 and 23.07.202 respectively, which would be the peak of monsoon season.

5. The items likely to be procured, and the proposed procurement details and method are outlined below;

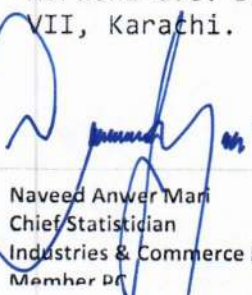

6. During the course of meeting it was further apprised that the main purpose of this meeting was to finalize specification of the goods, the bidding document, date of publication of NIT, last date of collection of bid documents, last date of submission of bids and opening of tender, tender fees and method of procurement.

7. Draft bidding documents that include all ToRs and detailed specification were placed before the PC, which was examined and discussed at length. It was also pointed out that the Bidding Document were finalized in light of the past experience. The PC, after deliberations, took the following decisions:

- i. The draft bidding documents were examined and the PC unanimously finalized and approved the bidding documents, which may be perused at "Annexure -A".
- ii. The draft Tender Notice document was examined and unanimously approved by PC (Annex-B)
- iii. The PC decides the dates of publication of Tender Notice, Last date of collection of bid documents, the last date of submission of bid and Date of opening of tender and method of procurement.
- iv. The tender fee was finalized at Rs.2,000/- non- refundable for each item/category.
- v. The tender Shall be single stage one envelope.
- vi. Tender Shall be opened through EPADS and at PDMA Head office Karachi i.e. Building No. C-26, Main Khayaban-e Jami, DHA, Phase-VII, Karachi.

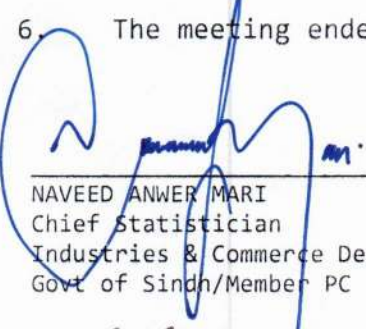

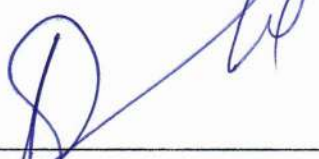
- vii. Procurement of Goods /Services as per NIT with specification was finalized.
- viii. The Earnest Money/Bid Security shall be 2% of the total allocated budget for tender item No. 01, 02, 03,04,09 and 10 as specified in the Revised Annual Procurement Plan 2024-25.
- ix. The Earnest Money/Bid Security shall be 2% of the total quoted value for item No. 05, 06, 07, and 08.
- x. The successful bidder shall be required to deposit a Performance Guarantee equivalent to 5% of the allocated budget for tender item No. 01, 02, 03, 04, 09 and 10 as specified in the Revised Annual Procurement Plan 2024-25 at the time of award of contract.
- xi. The successful bidder shall have to deposit performance guarantee to the tune of 5% of the quoted value at the time of award of contract for tender item No. 05, 06, 07, and 08.
- xii. The PC Shall start evaluating technical proposals following the next day of opening of tender through EPADS.
- xiii. Evaluation of samples shall be conducted through PC or technical committee and onsite inspection expenses shall be borne/ paid by the bidders.
- xiv. The PC recommends publication of the Tender Notice in the three leading newspapers of English, Urdu & Sindhi, which shall also be hoisted on PDMA Sindh, SPPRA/EPADS website as per govt policy.
- xv. The delivery time of the goods shall be five days from the award of the contract.

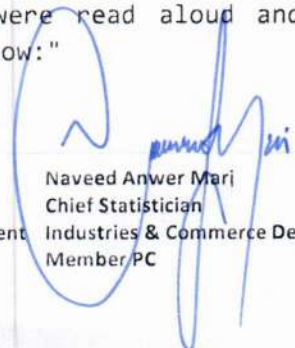
A meeting of the Procurement Committee constituted in pursuance of rule 7 of the SPP Rule-2010 and notified vide No. SO-I(Rehab)/3-14/2014/4016, dated:01.07.2024 regarding the procurement of Goods (office management) was held under the Chairmanship of Deputy Director (HQ&C), PDMA Sindh/ Chairman PC, on 11th June, 2025 at PDMA Head office Karachi at 1430 hours for opening of tenders through EPADS, as per schedule communicated vide NIT published in leading daily newspapers Jung dated 25th May 2025, Awami Awaz dated 25th May 2025 and Business Recorder dated 25th May 2025, hosted on PDMA website and EPADS (Tender No# S-250582805, 250582806, 250582807, 250582808, 250582809, 250582810, 250582812, 250582813). (The attendance sheets of the Procurement Committee members and participated venders/firms are attached as Annexure- "A" and "B").

2. After welcoming the PC members and participants/vendors to the meeting, the Chair informed committee members that the bids opening process is through EPADS and the tender will be opened as per given scheduled of bid opening date and time in the cited office address through EPADS, as per bidding process, the procurement Committee shall scrutinize the bids i.e. tender fee, 2% earnest money in compliance with Single Stage One Envelop procedure in the initial phase, hence the technical and financial bids shall be evaluated as per SPP Rules, 2010 (Amended from time to time).

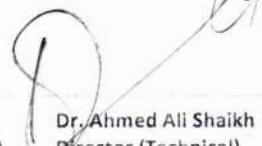
3. It was informed to all the participants that the bidders who qualify in the initial scrutiny shall be evaluated further by the Procurement committee and the inspection of items shall be conducted through PC and the Inspection cost if any shall be borne by the bidders at their warehouse/dealership or at PDMA HQ Karachi.

4. After the opening of bids, the committee found that none of the bidders had participated in the bidding process through E-PADS for tendered item category No. 1,2,3,4. However, only two bidders participated in the tendered item categories No. 5, 6, 7, and 8. Out of these, one bidder submitted bids for categories 5, 6, 7, and 8, while the other bidder participated only in category 8. Both bidders submitted the required bid securities and tender fees within the stipulated time and date. 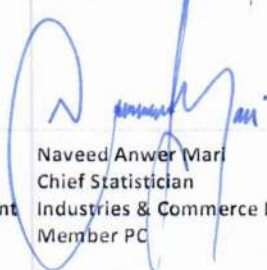

- That the detailed evaluation of bids for above procurement may be done in the next meeting of the procurement committee and recommendation would be finalized.



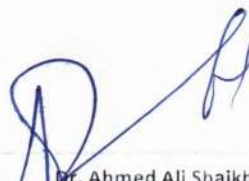
