MINUTES OF THE FIFTH PROCUREMENT COMMITTEE MEETING HELD ON 16TH MAY, 2024 AT 1500 HOURS FOR EVALUATION OF FINANCIAL BIDS FOR THE PROCUREMENT OF RELIEF ITEMS/ GOODS/ EQUIPMENTS FY-2023-24

A meeting of the Procurement Committee constituted in pursuance of rule 7 of the SPP Rule-2010 and notified vide letter No. SO-I(Rehab)/3-4/2014/3679, dated:15.11.2023 regarding procurement of relief items/goods/equipment was held under the Chairmanship of Deputy Director (HQ&C), PDMA Sindh/ Chairman PC, on 16th May, 2024 at PDMA Head office Karachi at 1500 hours for the evaluation of financial bids submitted by the bidders. - 2. The PC thoroughly examined and evaluated the financial bids in line with the bidding documents and SPP Rules. The opened financial bids item wise submitted by the qualified bidders may be perused at minutes of Fourth PC meeting for opening of financial bids held on 14.05.2024 at 1500 in PDMA Head office Karachi. - 3. The financial bids of technically qualified firms were opened before the members of PC and representatives of qualified bidders. The prices quoted along with bid security were read aloud and recorded the PC thoroughly examined and evaluated the financial bids in line with the bidding documents and SPP Rules.
