MINUTES OF MEETING OF PROCUREMENT COMMITTEE FOR OPENING OF FINANCIAL PROPOSAL AND EVALUATION OF FINANCIAL BID HELD ON 29TH JANUARY 2015 IN THE OFFICE OF THE PROVINCIAL DISASTER MANAGEMENT AUTHORITY KARACHI.

1. The meeting of procurement committee for opening of Financial Proposal& evaluation proposal for <u>Provision and Installation Deep Hand Pumps in Kohistan Areas District Jamshoro, District Thatta& District Dadu</u> was held under the chairmanship of Mr. Nazar Muhammad Bozdar, Director (F&A), PDMA Sindh / Chairman, Procurement Committee on 29th January 2015 at 2.00-PM in the Committee Room of Provincial Disaster Management Authority Sindh, Karachi.

- 3. The Tender Notice was published in leading dailies viz Daily the Express Tribune, Dunya Karachi, Awami Awaz, Express Karachi and Sobh, all dated 26th December 2014. The NIT was also hosted on the websites of SPPRA and PDMA Sindh.
- 4. Total forty-nine (49-Nos) Tenders/ Standard Bidding documents were sold to the Contractors/Firms. The tender Box was opened / unsealed on 14th January 2015 at 2.30-PM in presence of members of Procurement Committee and Participants.
- 5. Each of the envelope containing the proposal was shown to the participants and the name of the organization/ firm which submitted the bid was loudly announced .After scrutiny of the tenders only (8) tender were marketed as TECHNICAL PROPOSAL and (14) tenders were marked as FINANCIAL PROPOSAL while remaining (18) tenders were rejected by the procurement committee on spot being unmarked. Thus only (8) technical proposals of the firms were evaluated by the procurement committee as per rules 46(2) of SPPRA rule -2010 and all members of the committee signed the envelops . It is to highlight that the (9) Firms did not participate in the bidding process.
- 6. After scrutiny of the eight (8) technical Proposals, the Chairman informed the participants that eight (8) proposals have been evaluated by the Procurement Committee and only three (3) proposals are technically accepted. The result of Technical Evaluation was placed on SPPRA website. No grievance was received in this office up to date.
- 7. The seals of the tender box were opened by the procurement committee in the presence of the participants. Each of the envelopes containing the proposal was shown to the participants and the name of the firms was loudly announced, all the members of procurement committee signed the envelopes. The comparative Statements and Bid Evaluation Reports are attached.

8. The meeting ended with vote of thanks by the Chairman of the Committee.
