

1. The meeting of procurement committee for opening of technical bid & evaluation proposal for **Provision and Installation Deep Hand Pumps in Kohistan Areas (Districts Jamshoro, Thatta & Dadu)** was held on 14<sup>th</sup> January 2015 at 2.30-PM in the Committee Room of Provincial Disaster Management Authority Sindh , Karachi.

**Single Stage Two Envelops Bidding Procedure**


3. The Tender Notice was published in leading dailies viz Daily the Express Tribune, Dunya Karachi, Awami Awaz, Express Karachi and Sobh , all dated 26<sup>th</sup> December 2014. The NIT was also hosted on the websites of SPPRA and PDMA Sindh .

4. Total forty-nine (49-Nos) Tenders were sold to the Contractors/Firm (ANNEXURE-A). On submission of last date 14<sup>th</sup> January 2015 upto 2.00-PM , the seal of the tender Box was opened on 14<sup>th</sup> January 2015 at 2.30-PM in the presence of members of Procurement Committee and Participants, (ANNEXURE-B).

5. Each of the envelope containing the proposal was shown to the participants and the name of the organization/ firm which submitted the bid was loudly announced .After scrutiny of the tenders only (8) tender were marked as TECHNICAL PROPOSAL and (14) tenders were marked as FINANCIAL PROPOSAL while remaining (18) tenders were rejected by the procurement committee on the spot being unmarked. Thus only (8) technical proposals of the firms were evaluated by the procurement committee as per rules 46(2) of SPPRA rule -2010 and all members of the committee signed the envelopes.

6. The Financial Proposals of all the firms were sealed in the tender box in the presence of participants and the members of committee, the date of opening of Financial Proposal will be communicated to all members of Procurement Committee and participants as per SPPRA Rules.

7. The meeting ended with the vote of thanks from the Chairman of Committee.
