2. The Interested eligible bidders may either down load the detailed Bidding Documents for the relief goods having specifications mentioned and terms & conditions from websites of PDMA (<u>www.pdma.gos.pk</u>) and SPPRA (<u>www.pprasindh.gov.pk</u>) or can collect the Bidding Documents from PDMA Head Office during office hours from the date of publication of NIT till <u>12.04.2018</u> on payment of **Rs. 3000/-** for each item / relief package separately through Pay Order as Tender Fees (non-refundable) in favor of Provincial Disaster Management Authority Sindh. Those who download bidding documents from the website will have to submit the Tender Fees via Pay Order in the name of PDMA amounting to Rs.3000/- for each item / relief package separately, at the time of submission of bids. The last date to submit the bids is <u>13.04.2018 till 1430 hours</u>. Bids will be opened in the presence of bidders or their authorized representatives who choose to attend at <u>1530 hours on 13.04.2018</u> at the office of Director General PDMA, *Bungalow # 82, Lane No. 10, Khayaban-e- Hilal, DHA Phase-VI, Karachi*. Bids can be submitted for all or any of the items mentioned above along with 2 % earnest money in the form of Pay Order in the name of PDMA Sindh.

3. The proposal shall be submitted as single stage-two envelop; each envelop should consist of technical and financial proposal separately and should be clearly marked and placed inside a single envelop. The Bidders applying/ bidding for the Relief Packages must bid for all the items of that package. Bidders are required to provide samples for all the items for evaluation purpose except items No. 21, 23, 28, 29 & 30 for which the bidders are required to submit catalogue / user manual & onsite inspection will be conducted for the samples of item No. 24, & 25. The competent authority reserves the right to reject all or any bid thereof if the forms provided in the bidding documents are not duly filled (along with sign & stamp of the bidders) or submitted without relevant documents & the bids are not found in accordance with SPP Rules 2010.

4. The bidder are required to provide (Income Tax & Sales Tax) Registration Certificate, ISO Certificate(s), Manufacturing authorization certificate (for the relevant item(s)), Original manufacturer of the products will be give preference. In the case of bidding for the relief packages the bidders must also intimate / quote the prices of individual items of that relief package with the total quoted price of the relief package, supplier / bidder have minimum 05 year experience of supply.

5. Prices should include all applicable taxes & transportation charges (inclusive of loading / unloading charges) to the warehouses of PDMA Sindh . Successful bidders are required to supply 100 % delivery within 30 days of signing of agreement. Technical qualification criteria are available in the bidding document which will be strictly adhered to.
