REQUEST FOR QUOTATION

The Province of Khyber Pakhtunkhwa has been severely affected by extensive flooding, resulting in regrettable loss of human lives and infrastructure. In view of this situation, the government of Sindh has decided to provide Ration bags to flood affectees of Khyber Pakhtunkhwa Province. In this regard, Provincial Disaster Management Authority (PDMA), Sindh Rehabilitation Department, Karachi invites Quotations (with all applicable duties/taxes such as income tax, GST) from eligible bidders/ firms, who must be “Active Tax Payer” registered with the FBR (GST complied status) and who have their own distribution system and warehouses facility and should have the capacity to prepare minimum 4000 food packs per day, for the Procurement/supply of Ration Bags in accordance with section **Rule 16 (b) (viii) (Direct Contracting / incases of Emergency)** of Sindh Public Procurement Rules (SPPRA) 2010 amended till date and Section-32 of NDMA Act 2010. The ration bags shall be required to contain the following items and quantities;

S.No	Item	Item Description	Specification
01	Flour (Chaki Atta)	15 Kg	Fresh, clean, free from insects or moisture; refined wheat flour (chakki or mill ground), packed in food-grade plastic or cloth bag. Shelf life: Minimum 3 months.
02	Rice (Basmati) Supreme Quality	05 Kg	Clean, long grain white rice, free from stones, dust, packed in food-grade plastic or cloth bag. Shelf life: Minimum 6 months.
03	Daal Moong Supreme Quality	1.5 Kg	Washed split Moong dal, free from dirt, stones, or insects; uniform in size and color. Shelf life: Minimum 6 months.
04	Daal Masoor Supreme Quality	1.5 Kg	Washed split Masoor dal, clean and free from any infestation or impurities. Shelf life: Minimum 6 months.
05	Cooking Oil / Ghee	02 Kg	Pure vegetable oil (sunflower/canola, soybean, corn or equivalent), or Ghee banaspati (Dalda/ Sufi/Meezan or equivalent) sealed in leak-proof 1L or 2L pack are to be packed in double polyester and thick packing; fortified with Vitamin A & D. Shelf life: Minimum 6 months.
06	Crystal Sugar	01 Kg	Refined white crystal sugar, free from lumps and moisture. Packed in a sealed plastic bag. Shelf life: Minimum 6 months.
07	Tea Tapal Danedar / Family Mixture/Vital Tea or Equivalent	350 gram	Premium quality black tea, clean and dry, free from impurities. Packed in sealed foil or laminated pouch or in box. Shelf life: Minimum 12 months.
08	Milk Powder Everyday / Nido/Olphers or Equivalent	390 gram	Instant full cream or semi-skimmed milk powder, sealed in original branded packaging. Shelf life: Minimum 12 months.
09	Salt (Iodized) National Foods, Shan Foods or Equivalent	800 gram	Refined iodized salt, moisture-free, packed in a sealed plastic pouch. Shelf life: Minimum 12 months.

10	Red Chilie Powder Branded (National Foods Shan Foods, or Equivalent	200 gram	Pure, hygienic, and finely ground red chili powder; free from color additives. Packed in airtight packaging. Shelf life: Minimum 9 months.
11	Match Box 10 Pieces per pack (Hockey, Pajero or Equivalent)	01 Pkt	Standard size matchbox with 40–50 sticks per box; moisture-resistant packaging.
Ration bag's cover should be made of polyester bag (sealed). The logo of the Government of Sindh must be affixed on the Ration bags.			

Quotation may be submitted for the Ration Bags along with the following details;

- i. FBR Registration.
- ii. Active Tax Payer (Proof).
- iii. Sales Tax Returns for last one year 2023-24.
- iv. Company Profile details.
- v. The bidders shall submit an undertaking stating that the company/supplier possess the capacity of supplying minimum 4000 bags / day.

Additional Requirements

- i. The successful bidders are required to sign an agreement and pay stamp duty as per rules.
 - ii. Successful bidders are required to start their supplies immediately/24 Hours of the issuance of the Purchase order.
 - iii. Rates should be valid for 90 days from the submission of quotation.
 - iv. The firm should quote package rates while rates for individual item will not be accepted.
 - v. In case of delay in deliveries against issued PO, PDMA reserve the right to cancel the issued Purchase Order/contract.
 - vi. Bidder shall also mention their capacity of daily delivery of Ration Bags.
 - vii. Rates should include all applicable taxes, transportation and labour charges to the Governor's House Peshawar, Khyber Pakhtunkhwa (inclusive of loading/unloading, labor charges, Packing charges, bag charges, and logo printing price etc).
 - viii. The procured Ration bags shall be directly conveyed to the Governor House Khyber Pakhtunkhwa.
 - ix. To facilitate the expeditious distribution of ration bags to individuals impacted by the flooding, the authority may apportion the allocation of said ration bags among multiple vendors as deemed necessary.
2. The interested bidders who comply with all mentioned conditions may submit the quotation including transportation charges (with applicable taxes) in favour of Provincial Disaster Management Authority Sindh till 0300 PM 17.08.2025 at PDMA Sindh, Plot No 26-C, Main Khayaban-e-Jami, DHA Phase-VII, Karachi.
