REQUEST FOR PROPOSAL (RFP) FOR CONSULTANCY SERVICES
CONDUCTING BASELINE / FEASIBILITY STUDY FOR SEISMIC, TSUNAMI AND CYCLONE
HAZARDS ALONG COAST OF SINDH AND IDENTIFICATION OF SUITABLE SITES
FOR INSTALLATION OF MULTI-HAZARD EARLY WARNING SYSTEM.

The Rehabilitation Department through Provincial Disaster Management Authority, (PDMA) Government of Sindh, is mandated to execute Tsunami Early Warning System works in the public interest. The Department intends to take several protective measures to protect vulnerable public places and infrastructure from disasters like Tsunami, Earthquake and Cyclone Early Warning System for the said purpose, the Government of Sindh aims to hire the services of consultancy firms to conduct survey/ baseline study for site identification at coastal belt of Karachi Division, Badin Thatta and Sujawal Districts for installation of Tsunami Early Warning System (TEWS). The main objectives of this assignment shall be to conduct Baseline / Feasibility Study for Seismic, Tsunami Cyclone Hazards and associated Risk Assessment Coast of Sindh (Karachi Division, Badin Thatta & Sujawal Districts) and Identification of Suitable Sites for Installation of Equipment for Seismic monitoring, Tsunami Early Warning and Cyclone storm surge, track, intensity prediction System. The total cost of budget is Rs.15.00 million

For the execution of the project, the Provisional Department Management Authority Sindh (hereinafter shall be termed as "Client") requires services of a Consultancy Firm who shall Conduct Feasibility study for Seismic, Tsunami, Cyclone Hazards along Coast of Sindh and identification of Suitable Sites for Installation of Multi Hazards Early Warning System. More details of the required services are provided in Terms of Reference (TOR).

A Consultancy Firm will be selected under "**Quality and Cost Based Selection Method**" (QCBS) described in this RFP, in accordance with the Procurement Procedures set out in Sindh Public Procurement Rules 2010 issued by Sindh Public Procurement Authority (SPPRA).

(Necessary Conditions):

- The bid must remain valid for period 90 days effect from the technical bid opening date.
- The Bid security equivalent to 2% of the total quoted rate in shape of pay order/ bank guarantee.
- The bid containing technical and financial proposal sealed separately with all requisite documents.
- The last date of purchase of bid / RFP: 5.06.2023 at working hours.
- The last date of submission of bid / RFP: 6.06.2023 at 1400 hours.
- Date of opening of tender / RFP: 6.06.2023 at 1500 hours.
- The tender / RFP fee was finalized at Rs.2000/- non-refundable.
- The tender / RFP will be single stage two envelopes.
- RFP can be download from PDMA web site and SPPRA web site.
- Consultant must be registered with FBR /Income / Sale Tax, SRB and Survey of Pakistan, Ministry of Defense.
- In case of Joint venture (JV) firm must has separate NTN of JV.
- Proposal shall not be accepted after due date.
