Subject: MINUTES OF PRE BID MEETING OF THE PROCUREMENT COMMITTEE FOR THE PROCUREMENT OF TRANSPORTATION AND SKILLED MANPOWER SERVICES FOR PDMA SINDH HELD ON 02.07.2025 AT 1400

The meeting of the Procurement Committee, notified vide letter No. SO-I(Rehab)3-14/2014/5540 dated 01.07.2025, for the procurement of Services through EPADS for the FY 2025-26 for PDMA Sindh, was held under the chairmanship of the Deputy Director (HQ&C), PDMA Sindh, at the PDMA Head Office, Karachi, on 02.07.2025 at 14:00 hours. The list of participants is attached.

2. After welcoming the participants, the Chairman informed the committee that the Provincial Disaster Management Authority (PDMA) intends to initiate the procurement of transportation and rescue machinery, as well as skilled manpower services, through a Notice Inviting Tender (NIT). This is aimed at ensuring the timely transportation of relief items and the availability of rescue equipment in case of any emergency across Sindh. Additionally, the procurement of skilled manpower services is intended to operate the rescue machinery of PDMA Sindh during emergencies.

3. The Chairman further noted that the tenure of the transportation and rescue machinery, along with skilled manpower services currently hired through NIT during FY 2024-25, is set to expire on 31.07.2025 and 23.07.2025, respectively—which coincides with the peak of the monsoon season.

4. The purpose of this procurement is to ensure uninterrupted field and emergency operations, maintaining a state of preparedness for any emergent situations, so the authority would be requiring the transportation and skilled manpower services during monsoon 2025.


7. During the course of meeting, it was further apprised that the main purpose of this meeting was to finalize terms and conditions of the services, the bidding document, date of publication of NIT, last date of downloading of bid documents, last date and time of submission of bids and opening of tender, tender fees and method of procurement.

8. Draft bidding documents that include all ToRs and detailed specification were placed before the PC, which was examined and discussed at length. It was also pointed out that the Bidding Document were finalized in light of the past experience. The PC, after deliberations, took the following decisions:

- i. The draft bidding documents were examined and the PC unanimously finalized and approved the bidding documents, which may be perused at "Annexure -A".
- ii. The draft Tender Notice document was examined and unanimously approved by PC "Annexure -B".
- iii. The PC decides the dates of publication of Tender Notice, Last date of downloading of bid documents, the last date and time of submission of bid and Date of opening of tender and method of procurement.
- iv. The tender fee was finalized at Rs.5,000/- non- refundable for each item/category.
- v. The tender Shall be single stage one envelope.
- vi. Tender Shall be opened through EPADS and at PDMA Head office Karachi i.e. Building No. C-26, Main Khayaban-e-Jami, DHA, Phase-VII, Karachi.
- vii. Procurement of Services as per NIT with specification was finalized.
- viii. The Earnest Money/Bid Security shall be 2% of the total allocated budget for tender category mentioned at Sr.No. 01 and 02 as specified in the Annual Procurement Plan 2025-26.
- ix. Procurement of Services as per NIT with specification was finalized.


A meeting of the Procurement Committee constituted in pursuance of rule 7 of the SPP Rule-2010 and notified vide No. SO-I(REHAB)/3-14/2014/5540, dated:01.07.2025 regarding the procurement of services of Skilled Manpower was held under the Chairmanship of Deputy Director (HQ&C), PDMA Sindh/ Chairman PC, on 18th July, 2025 at PDMA Head office Karachi at 1600 hours for opening of tenders through EPADS, as per schedule communicated vide NIT published in leading daily newspapers express dated 03th July 2025, Kawish dated 03th July 2025 and Dawn dated 03th July 2025, hosted on PDMA website and EPADS (Tender No# S-250703125). (The attendance sheets of the Procurement Committee members and participated vendors/firms are attached as Annexure- "A" and "B").

2. After welcoming the PC members and participants/vendors to the meeting, the Chair informed committee members that the bids opening process is through EPADS and the tender will be opened as per given scheduled of bid opening date and time in the cited office address through EPADS, as per bidding process, the procurement Committee shall scrutinize the bids i.e. tender fee Rs. 5000/-, 2% earnest money in compliance with Single Stage One Envelop procedure in the initial phase, hence the technical and financial bids shall be evaluated as per SPP Rules, 2010 (Amended from time to time).

3. It was informed to all the participants that the bidders who qualify in the initial scrutiny shall be further evaluated by the Procurement Committee. As part of this evaluation, an inspection of the bidder's office, staff records, payroll, and deployment arrangements may be conducted by the Committee. Any cost related to such inspection shall be borne by the bidder, and it may be carried out either at the bidder's premises or at PDMA HQ Karachi.

4. As per NIT, the bidding process was single stage one envelope as per Rules 46(1) of SPP Rules-2010 amended time to time), The technical and financial proposals were opened simultaneously in the presence of the bidder or their authorized representative(s) who were present at the time of bid opening through EPADS. After the opening of bids, the committee found that only one (1) bidder had participated in the tender process. The required bid security and tender fee were submitted by the bidder within the stipulated time and date and the name of the bidder, quoted rates







After welcoming the members to the meeting, the chair informed the committee that total 01 nos. of bid were received through SPPRA EPADs portal and the bidder has submit the documents on EPADS along with Tender fees and 2% earnest money as Original Pay Orders in favor of PDMA (Sindh) before the opening of NIT, therefore, the committee may scrutinize the bid as per eligibility criteria. The bidding process was single stage one envelope as per (Rule 46(1) of SPP Rules-2010 amended from time to time), hence the technical bid was evaluated as per SPP Rules, 2010 (amended from time to time) and in accordance with the eligibility criteria.

3. The Procurement Committee (PC) had thoroughly examined and carried out evaluation of technical bid submitted by bidder as per evaluation criteria also an inspection of the bidder's office, staff records, payroll, and deployment arrangements was conducted by the Committee and finally decided to qualify the bidder in Bidders Qualification Report, the detail of responsive and non-responsive bidder (Qualified and disqualified) is as under;.
