**Subject WESTERLY WAVE PREVAILING OVER BALOCHISTAN LIKELY TO ACCENTUATE
FROM 29th FEBRUARY**

Pakistan Meteorological Department has informed that westerly wave prevailing over Balochistan likely to accentuate from **29th February**.

Under Its Influence: -

- Rain/Thunderstorm with few heavy falls likely in Kambar Shahdadkot, Jacobabad, Larkana, Shikarpur, Kashmore, Ghotki, Sukkur & Dadu from 29th February night to till morning of 2nd March.
- Rain/Thunderstorm with few heavy falls likely in Jamshoro, Thatta, Tharparker, Badin, Umerkot, Mirpur Khas, Hyderabad, Tando Allahyar, Tando Muhammad Khan, Naushahro feroze, Shaheed Benazirabad, Sanghar districts & **Karachi division** on 1st March.

Possible Impacts and Advises:

- Heavy falls may generate Urban flooding in low lying areas.
- Fishermen are advised to remain careful during the forecast period-

In view of the above, the Deputy Commissioner(s)/ Chairman DDMA(s), Line Departments and other relevant Authorities/ Stakeholders are requested to take necessary precautionary measures including:

- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.
- Ensure removal of vulnerable Billboards, Falling Trees, Loose Electric wires, Electric poles etc.
- Ensure coordination with Rescue 1122 Authorities.

For General Public

- Monitor the weather alerts through print media, electronic media, & social media.
- Stay indoor unless absolutely necessary. Keep doors and windows shut and avoid sitting near windows as rain is often accompanied by strong winds.
- Maintain a distance from power lines or electrical wires. If you notice any loose electric wires in your area, alert the authorities immediately.
- Avoid touching electrical switches or outlets while it is raining. Do not try using electrical sockets or outlets outdoors while it is raining.
- Avoid driving in heavy rain because of poor visibility.
- Avoid underpasses, drainage ditches, low-lying areas and areas where water collects.
- Check on family members who are especially at risk from weather hazards: young children, older adults, and the chronically ill
- Avoid parking near walls, Weak structure, & under trees.
