MORE RAINS IN SINDH

Subject: MONSOON RAINS FORECASTED BETWEEN 19-23 AUGUST 2022.

Pakistan Meteorological Department (PMD) vide its press release dated: 19.08.2022, has informed that the existing **low pressure area (LPA)** over upper Sindh will weaken in next 12 hours. However, another **low pressure area (LPA)** is likely to approach **Sindh** from **Tuesday, 23rd August, 2022**. Due to this weather system monsoon currents are penetrating in upper and southern parts of the country.

Under the influence of this weather system:

Rain-wind/thundershower (with isolated heavy falls) is expected in **Sindh** on **19-20 August** with occasional gaps.

- More rain-wind/thundershower (with few heavy falls) is expected in **Sindh** on **23 & 24 August**.

Possible Impacts:

- Heavy rains may generate urban flooding in **Sukkur, Dadu, Larkana, Jacobabad and Shaheed Benazirabad** on **19-20 August**.
- Heavy rains may generate urban flooding in **Hyderabad, Thatta, Badin, Mirpurkhas, Shaheed Benazirabad, Dadu, Sukkur Districts** and **Karachi Division** on **23rd and 24th August**.
- **Riverine flooding** in **Indus river** and its tributaries may occur during the forecast period.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.

- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
