MONSOON WEATHER OUTLOOK

Subject: MONSOON CURRENTS OF MODERATE INTENSITY ARE LIKELY TO ENTER INTO EASTERN SINDH FROM 4th AUGUST NIGHT/5th AUGUST MORNING

Pakistan Meteorological Department (PMD) has informed vide its Monsoon Weather Outlook, dated 02nd August, 2022, that, monsoon currents of moderate intensity are likely to enter into eastern Sindh from 4th August night/5th August morning.

Under the influence of this weather system:

Rain-thunderstorms with a few **moderate/heavy falls** is expected in **Tharparker, Umerkot, Mirpurkhas, Badin, TM. Khan, Tando Allayar, Hyderabad, Matiari, Thatta, Sujawal, Sanghar, Shaheed Benazirabad, Khairpur, Sukkur, Larkana, Ghotki, Kashmore, Shikarpur, Jacobabad, Dadu, Jamshoro & Kambar Shahdadkot** districts during 5th -9th August and in **Karachi division** during 6th -9th August.

Possible Impacts

- **Heavy falls** may generate **water-logging** in low lying areas of **Karachi, Badin, Thatta, Sujawal, Tando Muhammad Khan, Tando Allayar, Dadu, Jamshoro & Kambar Shahdadkot** districts during the forecast period.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.

- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
