**Subject** **HOT AND HUMID WEATHER IS LIKELY TO PREVAIL IN MOST PARTS OF THE PROVINCE**

Pakistan Meteorological Department has informed vide its Weather Outlook dated 31<sup>st</sup> July 2022, that, **hot and humid weather** is likely to prevail in most parts of the province. However, **isolated thunderstorm/light rain** may occur in **Sukker, Larkana and Jacobabad** districts, while **light rain/drizzle** along the coast including Karachi.

**Outlook for the next 48 hours:**

**Hot and humid weather** is likely to prevail in most parts of the province, while **light rain/drizzle** is expected along Sindh coast including **Karachi**.
